Oil Spill Recovery Institute (OSRI) - Established to support research, education and demonstration projects designed to respond to and understand the effects of oil spills in the Arctic and Subarctic marine environments. OSRI's current partnerships are focused on improving the Hydrological Modeling to assist the Ocean Circulation Forecast system in support of oil spill prevention and response. OSRI also partners with industry and government agencies to support new equipment and technologies, ecological studies and workshops, OSRI also provides for education programs, fellowships and internships.

4b (Code:) (Expenses \$ 2,944,760 including grants of \$ 0) (Revenue \$ 3,000,422)

Exxon Valdez Oil Spill (EVOS) Trustee Council - The EVOSTC has awarded PWSSC a five-year multi-million dollar program to continue monitoring the long-term effects of the Exxon Valdez Oil Spill. This program has two components. 1) Herring Research Monitoring (HRM) - PWSSC and other entity researchers work to improve our ability to predict herring populations, better understand aspects of the herring life cycle, overwinter food sources and bird predation. 2) Gulf Watch Alaska long term monitoring to understand the impacts of multiple ecosystem factors on the recovery of injured resources in the Exxon Valdez spill affected regions.

These funds received from the USCG Dept of Treasury are treated as federal for reporting purposes. These awards include grants and service contracts included in the work plan. Proposals are accepted through the advertised Request for Proposal (RFP) process or by a request for a proposal to a specific entity to meet the work plan needs. These proposals are peer reviewed by OSRI's Science & Technology Committee. If approved, they then go to the Board Chair (appointed by U.S. Secretary of Commerce) who approves. The grants are then awarded or amended if from prior years. Deliverables, financials and reporting expectations are included in the award documentation and the Grant Policy Manual is also found online on the OSRI web site www.pws-osri.org. Because the original source of these funds are from the Trans Alaska Pipeline Fund, these funds can be used for matching purposes on other federal awards.
